Lakeshore Intergenerational School opened in 2014 in the Collinwood neighborhood, and plans to grow to serve over 250 students in grades K-8. Students focus on achieving academic mastery within the context of our internationally innovative intergenerational educational model, where students learn in multi-age clusters and classrooms. Lakeshore Intergenerational School is the third Intergenerational School to open in Cleveland.

Our school connects, creates and guides a multigenerational community of lifelong learners and spirited citizens.

We are especially proud of our wonderful new partnership with Koinonia House – an organization whose mission is to work with people who have developmental disabilities to achieve healthy, fulfilling, enriched lives. We began with just a small group of individuals coming two days a week to assist in our lunch room

and with our PE classes, and we ended the year with groups coming 5 days a week! We provide a volunteer work environment for these individuals to learn a job skill, and our students learn about diversity and communicating with people who may be different. Koinonia House earned our IG Partner of the Year Award.



We are fortunate to include Slovene Home for the Aged in our list of local partners. They have done a tremendous job ensuring that our students and their residents are able to make the most of their time together. They generously offer their space and


