ABOUT E PREP AND V PREP CLIFFS

Breakthrough's flagship Preps model campus, Entrepreneurship Preparatory (E Prep) and Village Preparatory (V Prep) Cliffs are located in Cleveland's St. Clair-Superior neighborhood. V Prep serves grades K-4, and E Prep serves grades 5-8. A demanding college prep curriculum and a structured school culture prepare scholars to succeed in high school, college, or other post-secondary education and career.

Developing academic skills and entrepreneurial values, such as persistence, responsibility, and self-reliance, is essential to scholars' growth and education at E Prep and Village Prep Cliffs.

Ohio Revised Code (ORC) 3314.03(D)(2) specifies that the sponsor of the school must "monitor and evaluate the academic and fiscal performance and the organization and operation of the community school on at least an annual basis."

Buckeye Community Hope Foundation (BCHF) bases its evaluation of school performance on each of the State required indicators and performance measures listed in the charter contract. BCHF monitors the performance of the community school thru attendance at board meetings, bi-monthly visits to the school, monthly reviews of financial reports and quarterly reviews of academic progress reports along with several other reports relative to the school's performance. Buckeye Community Hope Foundation served as the sponsor for (NAME of Your School) during the 2021-2022 school year and found the school substantially compliant with the rules and regulations governing community schools and progressing towards compliant in academics.

All community school sponsors are required to submit a written report of the evaluation results of the school's academic, financial, and organization performance as well as the school's legal compliance to the Ohio Department of Education and make the report available to parents of students enrolled in the community school.
